The Chamber has had an active and productive year. From advocacy to trade facilitation, the Chamber has worked tirelessly to represent the best interests of the business community.

Advocacy for Development in Oil & Gas Sector

Through our newly formed and dynamic Petroleum Committee, the Chamber was able to achieve a number of things in the realm of advocacy as it relates to the oil and gas sector.

In May, the GCCI partnered with the Guyana Office for Investment (GO-Invest) to facilitate the participation of a Guyanese business delegation in the Offshore Technology Conference (OTC) in Houston, Texas. During this time, Guyanese businesses were able to network and conduct meetings with some of the largest companies in the oil and gas sector. Following the success of that event, the GCCI sent another trade delegation to Aberdeen, Scotland in September to participate in the SPE Offshore Europe Conference & Exhibition.

Local Content

Through our Advocacy Committee the Chamber has engaged multiple levels of government and policy makers on legislation and regulations that impact the petroleum industry. The Chamber has also been at the forefront of the conversation regarding local content. In August, the Chamber hosted a Local Content Forum at Duke Lodge. Feedback received from attendees and the Chamber's membership was compiled and used to prepare the Chamber's Position Paper on Guyana's Petroleum Sector Local Content Policy, which was recently submitted to the Department of Energy as a response to a request for commentary on the 3rd Draft of the Local Content Policy.

Improving the Standards of Local Businesses

In an effort to build the capacity and improve the standards and capabilities of local-agro-processors, the GCCI is undertaking a USD \$134,000 project titled, "Improving Standards of Agro-Processors Through Training." The project, which is being funded by the Caribbean Development Bank (CDB), aims to enhance the managerial, technical and operational capacity of micro, small and medium sized enterprises (MSMEs) in Guyana. Training will be provided in packaging and labelling, good manufacturing practices (GMP) and hazard access critical control point (HACCP).

Strengthening Cooperation with Counterparts

Continuing a culture of cooperation and information sharing, the GCCI signed an MoU with the Newfoundland and Labrador Oil & Gas Industries Association (NOIA) in October. Under the agreement, the GCCI and the NOIA will cooperate to provide each other with information relating to investment, trade and other opportunities within their respective locations, relating to the oil and gas sector. The GCCI signed a similar MoU in July with the Guyana Chamber of Commerce of Ghana.

Championing Diversity

It is the Chamber's mission to empower more women to take up leadership positions in the private sector. As such, through our newly formed Diversity Sub-Committee, the Chamber hosted a "Connecting Women in Business" Reception in October with the aim of offering professional women a unique opportunity to network

and make valuable business connections. The Chamber has also partnered Girls-in-Tech, a global non-profit organization focused on the empowerment of girls and women in IT, and will continue to keep diversity and inclusivity at the forefront of our strategic program.

Ensuring Growth and Sustainability for Local Businesses

Lastly, in keeping with our mandate to expand member opportunities and sustain growth, the GCCI hosted its second Annual Business Development Forum in September under the theme, "Evolve Your Brand, Fuel Your Finance." During the two-day forum, attendees, comprising mainly of start-ups and growing businesses, learned about topics such as digital marketing strategy, project proposal writing and innovative startup financing. For this event, the GCCI partnered with the Ministry of Business, the Inter-American Development Bank, Cacique Accounting College, Republic Bank Guyana Limited (RBGL) Ansa McAL Trading Limited. During this event, the GCCI also launched a \$300,000 grant for entrepreneurs. Attendees were asked to submit a business plan and applicants were judged against a given set of criteria including the business' capability, potential for growth, profitability and environmental benefits.
