#### GCCI hosts membership session with Ministry of Public Works on the energy sector and power outages

On November 6, the Georgetown Chamber of Commerce and Industry (GCCI) held a session for the membership with the Minister within the Ministry of Public Works, the Honourable Deodat Indar, where presentations and discussions were done on the operations of Guyana Power and Light (GPL), current load-shedding exercises, and the government's energy sector plans to address the country's growing electricity needs. Held at the Marriott Hotel, the meeting was also attended by a number of representatives from the GPL including Executive Team Leader, Mr. Kesh Nandlall, Finance Director, Mr. Loris Nathoo, and Deputy CEO (Strategic Operations), Mr. Bharat Harjohn. Minister Indar gave an extensive presentation on the government's current and future plans for dealing with power generation and transmission. Following Minister Indar's presentation, members of the GCCI were given the opportunity to ask questions and participate in an interactive discussion session.







GCCI President attends CBEE-R Stakeholder Workshop

On November 8, GCCI President, Mr. Hutson Caribbean **Business** attended the Enabling Environment Reform (CBEE-R) Activity stakeholder workshop hosted by the International Development Group (IDG) and the United States Agency for International Development (USAID). The purpose of the workshop was to discuss the activities IDG's technical team had prioritized for Guyana in four activity result areas: Internet Connectivity and Use Increased, and Open, Inclusive, and Secure Digital Economy Advanced; access to Digital Financial Services for Businesses Improvement; conditions for Firm Access to Finance: effective Public-Private dialogue established or enhanced.

## GCCI attends commissioning of NAMILCO \$1.6 billion new mixing plant

On November 8, GCCI Secretary, Mrs. Smith represented the Chamber at the commissioning of the National Milling Company's (NAMILCO) \$1.6 billion new mixing plant at the company's Agricola, East Bank Demerara location. The billion-dollar facility was commissioned as NAMILCO commemorated 54 years of doing business in Guyana. 
### GCCI attend welcome Reception for Commonwealth Parliamentary Association delegation

#### Disappointment with state of power outages

#### - START -

The Georgetown Chamber of Commerce and Industry (GCCI) wishes to express its profound disappointment with the continued state of power outages in Guyana.

The Chamber of Commerce notes that this continued spate of power disruptions is having an acute impact on the productivity of enterprises. The GCCI has also noted that this is cascading into general underperformance of enterprises. This continued loss of productive time, disruption to production and an overall hindrance to the smooth functioning of business will impede both growth and investment prospects.

The GCCI at this time wishes to reiterate its unwavering support for investments that will create a sustainable energy mix for Guyana including the Amaila Falls Hydropower Project, the Gas to Energy Project and Solar Farms. These projects, in the view of the Chamber, represent the future of Guyana's energy supply. However, the Chamber of Commerce also calls on the Guyana Power & Light and, by extension, the Government of Guyana to employ measures that will bridge the current generation shortfall.

The Chamber is also of the view that better forecasting, planning and investments into the energy sector will profoundly mitigate this bugbear on the life of the Guyanese people. Power outages have been decades-long feature of life in Guyana and, it is the hope of the Chamber of Commerce that this does not translate into life in our newfound status as a rapidly emerging economy.
