Building the capacity of farmers to meet the needs of an evolving market

-GCCI facilitates agriculture capacity-building workshop in Regions Three and Five



The Georgetown Chamber of Commerce and Industry (GCCI) continues to play a pivotal role in enhancing the capacity of local farmers to meet evolving market demands.

On June 4, GCCI's Agriculture Committee, chaired by Mr. Brian Edwards, organised an agriculture capacity-building workshop at the Belle West Multicomplex, West Bank Demerara, followed by a session in Blairmont, West Bank Berbice on June 27.

These initiatives saw collaboration with stakeholders like the World University Service of Canada, the National Agricultural Research and Extension Institute, the New Guyana Marketing Corporation, and the Pesticides and Toxic Chemicals Control Board, who provided insights on market access, good agricultural practices, and climate-smart innovations.

Additionally, the Small Business Bureau and the Guyana Bank for Trade and Industry (GBTI) offered information on financial access, including a \$300,000 collateral-free loan for poultry farmers.

Several farmers received pesticide storage cabinets during the workshops. These workshops have been held across various regions over the past years, aiming to equip micro, small, and medium-scale farmers with the knowledge required to thrive in a market increasingly reliant on high-quality produce due to rising import demands.

GCCI and Dominican Republic Chamber of Commerce in Guyana sign MoU for economic cooperation and promoting bilateral business relations



On June 3, the Georgetown Chamber of Commerce and Industry (GCCI) and the Dominican Republic Chamber of Commerce in Guyana (DRCham Guyana) signed a Memorandum of Understanding (MoU) geared towards promoting the development of business relations, bilateral trade, and investment between the Dominican Republic and Guyana.

President of the GCCI, Mr. Kester Hutson and President of DRCham Guyana, Mr. Miguel Angel Gonzalez Gottlieb signed the agreement at the office of the Dominican Republic Chamber of Commerce in Guyana, in Kingston, Georgetown. The basis of the MoU is a shared desire for the diversification of commercial exchanges and economic cooperation on a mutually advantageous basis between the members of the respective chambers.

This MoU is expected to facilitate the exchange of information on the possibilities of cooperation relating to products and services as well as promotional and marketing opportunities, legislation and regulations within the respective jurisdictions, and foster networking.

GCCI President lobbies private sector to combat hate speech



President of the Georgetown Chamber of Commerce and Industry (GCCI), Mr. Kester Hutson on June 18, urged members of the private sector to utilise their influence and public platforms to combat hate speech and foster inclusivity.

Mr. Hutson was at the time addressing the launch of the 'National Campaign on Hate Speech' at the National Library, Georgetown. The campaign launch coincided with the International Day for Countering Hate Speech, and was a collaborative effort between the United Nations (UN) and the Ethnic Relations Commission.

The GCCI President stated that hate speech is a poison that fuels discrimination, violence and social unrest, and the eradication of this social scourge requires collective action. "As private sector leaders, we have a unique platform to promote inclusivity, diversity, and respect. We can leverage our influence to create a culture of empathy and understanding. We can use our marketing channels, social media, and community outreach programmes to spread positive messages and counter hate speech," he posited.

The GCCI is committed to its role of countering discrimination and promoting inclusivity. In 2023, the Chamber and the UN Resident Coordinator's Office signed a Joint Declaration of Intent for cooperation in meeting the 2030 Agenda for Sustainable Development in Guyana, which included an agreement to enlist the private sector as a critical advocate of the elimination of hate, and the promotion of human rights.

SMALL BUSINESS TIP

Prioritise two-way Communication: Effective communication in the workplace involves speaking, active listening, and feedback. Both parties need to understand each other.

Practice active listening: To avoid missing important information, don't listen to a coworker just so you can reply. Instead, listen to understand them. Maintain eye contact with the speaker, jot down whatever comes to your mind while they're speaking, and respond with relevant gestures to show you're listening.

Embrace feedback: Ask your team members for feedback on your message and communication style, and note their comments and concerns. They can share such information during meetings or drop them anonymously in suggestion boxes. You can also offer feedback, but do it thoughtfully.

GCCI supports Traffic Department in capacity-building session for stakeholders



In keeping with its core values of commitment and collaboration, the Georgetown Chamber of Commerce and Industry (GCCI) on June 22, engaged the Guyana Police Force's Traffic Department and the National Road Safety Coordinator during the monthly stakeholder meeting at the Officer's Training Center, Eve Leary, Georgetown.

The engagement saw court prosecutors, inspectors, traffic officers, and certifying officers benefiting from capacity-building on traffic education and enforcement. Discussions were led by Traffic Chief, Senior Superintendent, Mahendra Singh and Deputy Traffic Chief, Superintendent Shellon Daniels. GCCI Security and Governance Committee Chairperson, Mr. Paul Archer, and Committee Members Ms. Shaleeza Shaw and Mr. Charles Williams were in attendance.

Mr. Williams, who addressed the gathering, iterated the importance of collaboration between the private sector and the GPF, saying, "This partnership is crucial as it allows us to combine resources, share knowledge, and develop strategies that enhance public safety and efficiency. By working closely together, we can better understand the challenges each side faces and develop comprehensive solutions that benefit the entire community."

Mr. Williams also provided guidance on public interactions, with the objective of fostering a better relationship between members of the Police Force and the public. He underscored the importance of mutual respect and trust between the private sector and the Police Force, noting that this can lead to a more resilient and cohesive society through the implementation of innovative solutions and the leveraging of new technologies. This initiative follows a meeting on June 19 between the GCCI and the Traffic Department, during which the Chamber committed to collaborating with the GPF for the promotion of road safety.

SMALL BUSINESS TIP

Build Your Communication Skills: Effective workplace communication starts with you developing good communication skills.

Be clear: To communicate effectively, be clear about your goal, use easy-to-understand words and avoid incomplete sentences. Also, provide context when communicating with your team. For example, when setting expectations, share samples and highlight the groups that should be involved and those that will be affected by the output. Also, encourage employees to ask questions to minimise errors and maximise productivity.

GCCI participates in ongoing National Skills Audit



The Georgetown Chamber of Commerce and Industry (GCCI) continued its participation in the National Skills Audit, with Chairperson of the Entrepreneurship and Small Business Committee, Mrs. Evie Kanhai-Gurchuran engaging in the review of the questionnaire that will be used.

On June 13, Mrs. Kanhai-Gurchuran joined a number of stakeholders including the Ministry of Public Works, Ministry of Education, Ministry of Natural Resources, the Board of Industrial Training, and the Canada-Guyana Chamber of Commerce at the Guyana Tourism Authority's Conference Room, where the questions on the datagathering tool were scrutinised. Mrs. Kanhai-Gurchuran highlighted the importance of studying the impact of culture on the labour force, particularly as it relates to women, and as such she recommended that the inquiries provide room for this area to be probed.

It is anticipated that in five years, Guyana will need an additional 52,000 skilled workers; however, there exists a deficit. The National Skills Audit was commissioned by the Government of Guyana under the Strengthening Human Capital through Education Project and is being conducted by Dunn, Pierre Barnett, and Company Canada Limited (DPBA) with a view of providing baseline information for the upskilling of the local labour force. In February, the GCCI met with DPBA and made initial contributions to the study as it relates to challenges facing the private sector in regard to human capital.

GCCI presents recommendations for monetisation of Guyana's natural gas

The Georgetown Chamber of Commerce and Industry (GCCI) engaged SP Global, the company that was contracted by the Government of Guyana to craft the country's Gas Monetisation Strategy.

Chairperson of the GCCI's Green Economy Committee and Councillor, Mr. Delmar Walcott met with the team from SP Global at the Ministry of Natural Resources on June 13. During the meeting, Mr. Walcott presented several suggestions on the utilisation of the country's natural gas that will be transported onshore via a pipeline at Wales, West Bank Demerara, including the establishment of a local liquefaction plant for the gas to be containerised and distributed around Guyana, particularly for the benefit of the manufacturing sector.



He highlighted that the gas could be supplied to local transportation and accommodation industry players.

Fostering diversity and inclusion in the business arena -GCCI and SASOD collaborate for Pride mixer

On June 28, the Georgetown Chamber of Commerce and Industry (GCCI) partnered with the Society Against Sexual Orientation Discrimination (SASOD) for the hosting of the second annual Pride Month Mixer. The event was coordinated by the Chamber's Membership and Diversity Committee and hosted at 'Fresh' restaurant. Members of the LGBTQ community were able to meet and interact with Councillors of the GCCI, and they were provided the opportunity to have their businesses become members of the Chamber.

GCCI Executives meet with ExxonMobil Guyana team

-Lobbies for open dialogue and information-sharing for members' benefit

On May 29, a team from ExxonMobil Guyana visited the Georgetown Chamber of Commerce and Industry (GCCI) and met with several members of the Executive Committee to discuss areas for collaboration.

President of the GCCI, Mr. Kester Hutson; Councillor and Executive Member, Mr. Richard Rambarran; Senior Vice President, Mrs. Kathy Smith and Chairman of the Agriculture Committee, Mr. Brian Edwards engaged ExxonMobil Guyana's Production Manager, Mr. Huzefa Ali and Government Relations Advisor, Ms. Teijvarti Persaud on the Chamber's history, role, objectives and achievements.

The GCCI iterated its focus on strategic collaboration, and the push for sustainability, equity and continuity among members, while also lobbying for open dialogue on relevant matters such as local content development and payment timelines.



Among the potential areas for engagement discussed was a call by the GCCI for increased information-sharing and industry updates for members' benefit.

The ExxonMobil Guyana team expressed their desire to work closer with the GCCI and be more active in their engagements.

GCCI and CDB discuss capacity-building initiatives for agri-sector

The Georgetown Chamber of Commerce and Industry (GCCI) and representatives of the Caribbean Development Bank (CDB) met to discuss the pursuit of several capacity-building initiatives that will benefit Micro, Small and Medium-sized Enterprises (MSME) in Guyana, with special focus on the agriculture sector particularly small-scale farmers.



In attendance at the meeting were the CDB's Micro, Small and Medium-Sized Enterprise (MSME) Consultant, Ms. Allyson Francis and Senior Operations Officer, Mr. Michel Thomas, and a team from the GCCI that included Senior Vice President, Mrs. Kathy Smith; Councillor and Executive Member, Mr. Richard Rambarran; Treasurer and Chairperson of the Agriculture Committee, Mr. Brian Edwards, and Trade and Investment Consultant, Ms. Jessica Campbell.

Discussions revolved around the 'Improving Quality Standards of Agro-Processors through Training' Project, and expanding current initiatives that are geared towards capacitybuilding such as funding the Hazard Analysis and Critical Control Point (HACCP) certification for agro-processors. HACCP is a food safety management system that caters to the analysis of food safety hazards from production to consumption of a product, which will enable agro-processors to establish safe and proper production environments.

There is also keen interest in introducing new programmes that target women farmers, in order to empower them to grow crops that they can transform into value-added products.

Chairperson of the Entrepreneurship and Small Business Committee, Mrs. Evie Kanhai-Gurcharan and Secretary of the GCCI, Mrs. Melisa McRae-George met with IPED's Chief Executive Officer, Mr. Jagdesh Haripershad, and Business Development/Marketing Manager, Mr. Robert Williams.

The discussions centered on providing training for members of the Chamber as well as ease of access to lowinterest financing, particularly for the benefit of micro and small businesses. These engagements are in keeping with the GCCI's mission to stimulate trade and investment and expand member opportunities.

GCCI engages Local Content Secretariat on Local Content Legislation



In June, Senior Vice President, Mrs. Kathy Smith, Advocacy, Business and Economic Affairs Committee Members—Mr. Devon Seeram and Mr. Nicholas Deygoo-Boyer, and Councillor, Mr. Richard Rambarran engaged the Local Content Secretariat on several issues related to the implementation of the Local Content Act and potential updates to the legislation.

Among the areas of discussion were the deregistering of companies that lose their Local Content Certificate, the publication of ExxonMobil's prime contractors' in-country spend, re-examination of the percentage requirements for nationalisation of general labor and senior management roles, flouting of the local content legislation, and amendments to the niche areas for Guyanese companies to include 23 additional areas.

The Georgetown Chamber of Commerce and Industry (GCCI) is continuing its collaboration with the United Nations (UN) Resident Coordinator's Office in propelling the attainment of the UN Sustainable Development Goals (SDGs).

On June 12, the Executive Management Committee of the GCCI met with a team from the UN to discuss the implementation of a Joint Declaration of Intent signed in 2023 by the GCCI and the UN's Office of the Resident Coordinator, for cooperation in meeting the 2030 Agenda for Sustainable Development in Guyana.

President of GCCI, Mr. Kester Hutson; Junior Vice President, Mr. Gavin Ramsoondar; Councillor and Ex-Officio Member, Mr. Richard Rambarran, and Treasurer, Mr. Brian Edwards met with UN Resident Coordinator, Ms. Yesim Oruc; Head of the Resident Coordinator's Office, Mr. William Evans; Communications Officer of the Resident Coordinator's Office, Mrs. Colette Hytmiah-Singh; Programme Analyst for Poverty and Governance of the United Nations Development Programme, Ms. Nadira Balram; Communications Associate and Business Portfolio Lead of UNICEF Guyana/Suriname, Mr. Frank Robinson, and Planning and Coordination Specialist of UN Women, Ms. Akilah Dorris.

Special focus was placed on 'sustainable development in business', particularly relating to labour practices and child rights. The GCCI highlighted the establishment of the Agriculture and Women in Business Committees, as well as the policy of a third of the Council being women, which are aligned with the SDGs. Considerations for the amending of the Code of Conduct to reflect more sustainable development elements were also discussed.

SMALL BUSINESS TIP

Stay open-minded: Make sure your employees feel comfortable approaching you with ideas or concerns. That means you must keep considering their thoughts and attending to them respectfully, even when busy. And if you have concerns about an employee's behavior or performance, discuss it with them instead of making assumptions.

GCCI and GPF Traffic Department discuss collaborative initiatives to address road safety

On June 18, President of the GCCI, Mr. Kester Hutson; Chairperson of the Security and Governance Committee, Mr. Paul Archer, and Committee Members Ms. Shaleeza Shaw, Mr. Sean Kirkpatrick, Mr. Sean Ramrattan, Mr. Tyrone Williams and Mr. Rayad Boyce met with Traffic Chief, Senior Superintendent Mahendra Singh, Sergeant Richard Trotz and Sergeant Nicholas Higgins.

The Traffic Chief took the opportunity to share some of the challenges that the Traffic Department is facing, including increasing cases of Driving Under the Influence of alcohol, speeding and inattentive drivers, inconsiderate use of the roadways and poorly maintained vehicles, while the team from the GCCI shared these concerns, noting that the increasing number



of accidents and road fatalities are a grave concern to the Chamber. The two parties discussed collaborative initiatives that can be executed to raise road safety awareness among the members of the Chamber as well as the general public and agreed to execute the activities discussed.

SMALL BUSINESS TIP

Get a Team Communication App: Without good team communication, there will be miscommunications, especially since many organisations are now hybrid or remote. But with team communication platforms, whether UCaaS or CPaaS, employees can communicate, stay up to date and collaborate on projects. They can meet to carry out their tasks, share relevant information and discuss upcoming tasks. Communication apps include project management tools, video conferencing tools and voice-over-internet-protocol services.


