#### Farmer-to-Business Symposium 2025



The Georgetown Chamber of Commerce and Industry (GCCI) on April 2 held a 'Farmer-to-Business Symposium' at the Splashmin's Conference Room that saw over 90 participants—including farmers, and representatives of restaurants, supermarkets, and other businesses within the agriculture supply chain—benefiting from direct engagement between producers and buyers.

The event was organised by the GCCI's Agriculture Committee in collaboration with World University Services of Canada (WUSC) with funding from Global Affairs Canada, and hosted under the theme "Opportunities in Agriculture through Innovation and Collaboration." The goal of the event is the development of a sustainable and robust agriculture market system that promotes food security, boosts productivity, and drives economic prosperity for farmers by enhancing competitiveness, sustainability, and inclusivity through commercialisation and modernisation.

The event also sought to provide a platform for farmers to share their challenges and issues related to access to agricultural innovations, inputs, finance, and government support, and equip them with the necessary knowledge and skills to adapt to a changing agricultural landscape and thrive in the market. Among the activities at the symposium was a 'speed dating for stakeholders' session, which saw farmer and businesses interacting in order to develop a supply chain connection.

This symposium also brought together stakeholders from key agencies such as the Ministry of Agriculture, the National Agriculture Research Extension Institute (NAREI), the New Guyana Marketing Corporation, the Guyana Food Safety Authority, the Small Business Bureau, the Food and Drug Administration, the Tourism and Hospitality Association of Guyana, the Pesticide and Toxic Chemicals Control Board and Guyana Bank for Trade and Industry.

#### GCCI Council walkabout



The President and Councillors of the Georgetown Chamber of Commerce and Industry (GCCI) on April 10 continued a walkabout in Georgetown to meet with members of the business community to better understand the support that they need and areas of collaboration.

President, Mrs. Kathy Smith; Senior Vice President, Mr. Gavin Ramsoondar; Treasurer, Mrs. Melisa McRae-George; Secretary, Mrs. Kristia Ramlagan-Prescott; Councillor and Executive Member, Mr. Richard Rambarran, and Councillor and Chairperson of the Trade and Investment Committee, Mr. Eusi Evelyn visited businesses in North Cummingsburg, Georgetown. The businesses included Hallmark, Kings Jewellry, John Lewis Styles, Vivaanta Ayurvedic Spa, Reaz Computer Centre and Gizmos and Gadgets.

The interactions saw fruitful discussions on challenges being experienced by these businesses and recommendations on the type of support they need in areas such as human resources as well as improvement in their business environs that would lead to increased opportunities to meet their customers' needs.

This initiative will continue in the coming weeks as the Chamber seeks to support the development and advancement of the business community.

#### GCCI hosts session with ExxonMobil Guyana



The Georgetown Chamber of Commerce & Industry (GCCI), through its Petroleum Committee, hosted an engagement session with ExxonMobil Guyana (EMGL), providing Chamber members with the opportunity to learn more about the company's operations and future plans within the energy sector.

"As Guyana's energy sector grows, the role of local businesses becomes even more important," said Kathy Smith, President of the GCCI. "We're focused on ensuring the right environment for our members to succeed."

Alistair Routledge, President of ExxonMobil Guyana, shared key insights into the company's operations, upcoming gas development projects, and the many opportunities available for local businesses to participate. He also highlighted EMGL's commitment to improving operational efficiency and increasing local workforce participation, underscoring the importance of strong partnerships with the business community.

Chairman of the Petroleum Committee, Richard Rambarran, noted that this session forms part of the continued build-out of the Chamber's efforts to consistently engage its membership. "You'll find us continuing to do the same thing in the near future as we expand our focus across various sectors and sub-sectors," he stated.

The GCCI will continue to bridge the gap between the private sector and major industry players, helping local businesses to leverage emerging opportunities in Guyana's rapidly developing energy landscape.

#### **Guyana Agri Connect**



With support from Global Affairs Canada, the GCCI and WUSC Caribbean recently hosted a dynamic Partnership Engagement Session, bringing together key players from the public and private sectors and NGOs—including National Agricultural Research and Extension institute, New GMC, The Pesticides and Toxic Chemicals Control Board, Guyana Livestock Development Authority, Government Analyst Food and Drug Department, Small Business Bureau, Guyana Bank for Trade and Industry, Institute of Private Enterprise Development, Farfan & Mendes, Green Agro Services & Supplies Inc. and Tourism & Hospitality Association of Guyana.

Over the past three years, many of these partners have been working directly with farming communities across Guyana. Now, under the banner of Guyana Agri Connect, they're joining forces to formalize partnerships and scale up impact through a shared Partnership Framework.

The mission? Support farmers—especially women and youth—with real, practical solutions to increase productivity, income, and market access. From training in good agricultural practices to entrepreneurship, finance, leadership, and extension services, this collaboration is delivering results.

#### **MEETINGS**

#### **GCCI** meets with Minister of Natural Resources



With focus on important issues and concerns surrounding the development of local companies—including Micro, Small and Medium Sized Enterprises—including the establishment of a financial institution catering to their needs, as well as increasing local content utilisation, the Georgetown Chamber of Commerce and Industry (GCCI) on April 2 met with Minister of Natural Resources, Hon. Vickram Bharrat.

President, Mrs. Kathy Smith; Secretary, Mrs. Kristia Ramlagan-Prescott; and Treasurer, Mrs. Melisa McRae-George made a courtesy visit to the minister at his Duke Street, Georgetown office. Mrs. Smith provided the minister with an overview of the recently held Annual General Meeting of the Chamber, and the newly elected Executive Management Committee and Council.

In her discussions with Minister Bharrat, Mrs. Smith pointed out that the GCCI's membership has significantly increased over the last several years with many members being able to tap into the oil and gas industry. On this note, she indicated the GCCI's keen interest in the updating of the Local Content Schedule, adding that the Chamber is desirous of making further input—particularly in increasing the percentage of contracts carved out for local companies. Minister Bharrat assured the Chamber that the proposed updates will be shared for further consultation.

Additionally, the GCCI President engaged the minister on concerns related to fronting and unethical practices by foreign businesses that partner with Guyanese companies, such as 'double-dipping'—issues which she stated requires penalisation. In terms of capacity building, Mrs. Smith provided insights into the Micro and Women Entrepreneur Learning Centre that is under development at the GCCI, and how it will positively impact MSMEs by providing a platform for their advancement, while advocating for concessions for Guyanese businesses.

Minister Bharrat shared that, aligned with the objectives of the GCCI, the government is examining mechanisms to develop MSMEs, one of which is the facilitation of financing with lower interest rates and easier accessibility. The Minister, in committing to continuing the collaborative relationship with the Chamber, indicated that a team from the Ministry would further engage the GCCI on further improving the local content legislation.

#### GCCI and International IDEA discuss electoral integrity



The International Institute for Democracy and Electoral Assistance (International IDEA)—an intergovernmental organisation that supports democracy worldwide through supporting the building, strengthening and safeguarding of democratic political institutions and processes at all levels—met with the Georgetown Chamber of Commerce and Industry (GCCI) on April 2 to discuss plans for elections awareness and voter education with the broader objective of supporting electoral integrity as Guyana approaches the 2025 General and Regional Elections.

Resource Mobilisation and Partnerships Advisor, Mr. Luis Jose Consuegra; Programme Manager, Mr. Marcelo Varela, and Programme Assistant, Mr. Junior Chanderpaul met with President of the GCCI, Mrs. Kathy Smith and Secretary, Mrs. Kristia Ramlagan-Prescott. Discussions revolved around International IDEA's plans for engaging in voter education, a project which is being funded by the European Union's Delegation to Guyana. The International IDEA team provided an outline of its scope which includes civil society capacity building, voter education and tackling misinformation. It was also indicated that they will be collaborating with the Guyana Elections Commission to gather official information via the Commission's manuals and handbooks.

President Smith, during the discussions, noted that the GCCI has over the years been an active Election Observer, with members travelling across the country on election day in fulfilment of this role. She emphasised the Chamber's position on the need for a democratic process that respects the rule of law. "We want to ensure our election this year is free, fair and transparent. We don't want what happened in 2020 to happen again as it will stymie and impede business," she firmly stated, later adding, "Business must continue, and it must continue smoothly."

She shared that the GCCI is in the process of meeting with political parties to discuss their economic strategies for Guyana and their plans for elections, noting that a similar engagement is being sought with GECOM.

#### **GCCI Councillors meet with Ministry of Home Affairs**



The Georgetown Chamber of Commerce and Industry (GCCI) on April 2 engaged Minister of Home Affairs, Hon. Robeson Benn on crucial matters of national importance, including reducing the number of accidents on the roadways, road safety awareness initiatives, fire safety, traffic management and the availability of parking in the city, and the upcoming General and Regional Elections.

President, Mrs. Kathy Smith; Secretary, Mrs. Kristia Ramlagan-Prescott; Treasurer, Mrs. Melisa McRae-George; Councillor and Chairperson of the Entrepreneurship and Small Business Committee, Mr. Orson Ferguson, and Councillor and Chairperson of the Governance and Security Committee, Mr. Paul Archer paid the minister a courtesy visit at his Brickdam, Georgetown office during these discussions were held.

The GCCI Councillors also commenced talks on collaborating with the ministry to host awareness sessions with its membership on the country's immigration laws and the ministry's immigration services.

## GCCI and Minister of Parliamentary Affairs discuss collaboration on anti-corruption initiatives, elections and increasing stakeholder consultations



President of the Georgetown Chamber of Commerce and Industry, Mrs. Kathy Smith; Secretary, Mrs. Kristia Ramlagan-Prescott; Councillor and Executive Member, Mr Richard Rambarran, and Minister of Parliamentary Affairs, Hon. Gail Teixeira on April 2 discussed a wide range of issues including collaborating for increased government stakeholder consultation with the GCCI and increasing education on anti-corruption practices and measures within the private sector, as well as preparations for the upcoming General and Regional Elections.

The GCCI Executives paid a courtesy visit to the Minister at her office during which they engaged her on these areas. Minister Teixeira noted that as the lead coordinating body for reports required as part of Guyana's Treaty Reporting commitment which includes anti-corruption framework, particularly the Inter-American Convention against corruption, one of the focus areas is the inclusion of the private sector in anti-corruption practices and measures. As such, she was pleased with the Chamber's expression of interest in increasing collaboration. Mr. Rambarran noted that the GCCI's Code of Conduct, that speaks to anti-corruption and dissuading corrupt practices, allows for removal of members for violations. He stated that the Chamber is interested in integrating these anti-corruption frameworks being implemented by the Ministry into this Code of Conduct.

Of importance, too, were discussions surrounding the flouting of Local Content laws via loopholes by foreign companies operating in Guyana's oil and gas industry. President Smith stated, "Some of the large companies are creating multiple companies to access the opportunities that are there for smaller businesses. In some cases, too, the local partners are only partners on paper—they are not getting the benefits that they ought to." As such, she raised this issue with the minister as it is one of the matters the Chamber is seeking to address frontally. Talks also delved into the upcoming General and Regional Elections and preparations for polling day.

#### GCCI officials meet with Minister of Tourism, Industry and Commerce



The Georgetown Chamber of Commerce and Industry (GCCI) on April 3 engaged Minister of Tourism, Industry and Commerce, Hon. Oneidge Walrond-Allicock on several issues including the recently imposed tariffs, access to finance, elections and increasing collaboration, among other issues.

President, Mrs. Kathy Smith; Secretary, Mrs. Kristia Ramlagan-Prescott; Treasurer, Mrs. Melisa McRae-George; and Councillor and Chairperson of the Entrepreneurship and Small Business Committee, Mr. Orson Ferguson paid the minister a courtesy call at her office.

President Smith took the opportunity to raise concerns related to the need for digitalisation of services provided by the public sector, noting that the paper-based system and bureaucratic systems can frustrate business. On the issue of access to finance, the Minister—in response to the President's advocacy for increased access to capital for micro, small and medium-sized enterprises—stated that mechanisms to address these are being examined and requested data from the Chamber to support this process.

Other matters included Non-Tariff Barriers and General and Regional Elections.

#### GCCI pays courtesy call on British High Commissioner



As the Executive Members and Council of the Georgetown Chamber of Commerce and Industry (GCCI) continue with its courtesy visits to various government officials and the diplomatic community, President of the Chamber, Mrs. Kathy Smith; Secretary, Mrs. Kristia Ramlagan-Prescott, and Executive Member and Councillor, Mr. Richard Rambarran met with British High Commissioner, Her Excellency Jane Miller OBE.

On April 4, the GCCI officials met with H.E Miller, alongside her team that included Country Director for Trade and Investment, Department for Business and Trade, British High Commission, Guyana and Suriname, Mr. Sherwyn Naughton; Country Trade and Investment Officer at British High Commission, Mrs. Kimberly Singh-Hanoman, and Trade and Investment Assistant, Mrs. Faith Trim-Browne.

The two parties discussed a number of important matters including local content development and utilisation, increasing bilateral trade as well as inbound and outbound trade missions, Guyana's Human Resource needs, continuing collaborations, and skills development for both the labour force and Micro, Small and Medium-sized Enterprises.

## GCCI participates in Caribbean Ministers of Labour Conference



The Georgetown Chamber of Commerce and Industry (GCCI) on April 7 attended the 13th International Labour Organization (ILO) Caribbean Ministers of Labour Conference at the Arthur Chung Conference Centre.

President, Mrs. Kathy Smith and Treasurer, Mrs. Melisa McRae-George attended the conference that focused on key topics such as the ratification and implementation of International Labour Standards and Labour Laws in the Caribbean, social protection, skills development, lifelong learning, and occupational safety and health.

These focal points are aligned with the GCCI's work plan as it relates to workforce development, capacity building, and addressing labour shortages.
